## Invoicing

Purchase orders should be supplied by the company to the Film Calderdale Office (where one needs to be referenced on the invoice). The Council's invoice will include an IN\*\*\*\*\*\*\* number which needs to be referenced on payment. Payment methods are to be found on the invoice.

## **Cancellation/refunds**

Please read the pricing schedule for details relating to non-refundable items. If you need to cancel your shoot, as soon as possible, please email <u>eventsandfilm@calderdale.gov.uk</u> - quoting your permit reference number and programme name.

A cancellation fee of 50% of the total sum owed is payable (once a permit is issued) if more than 48 hours' notice is provided before the shoot start time. If less than 48 hours' notice is given in writing, the full sum is payable. We know that filming requirements can change regularly and often at short notice, and we will do our upmost to ensure flexibility. However, depending on the application, costs may have been incurred that will need to be covered, we will endeavour to inform you of these as soon as possible.
